#### THE BOROUGH OF DACORUM (CONTROLLED PARKING ZONES) (AMENDMENT NO. 1) ORDER 2019

Dacorum Borough Council, pursuant to arrangements made under section 19 of the Local Government Act 2000¹ and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2012² with Hertfordshire County Council, and in exercise of the powers conferred on that County Council under sections 1, 2, 4, 45, 46, 47, 49, 51, 53 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984³ ("the Act of 1984") and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

- 1. This Order may be cited as the Borough of Dacorum (Controlled Parking Zones) (Amendment No. 1) Order 2019 and shall come into force on 1 November 2019.
- 2. (1) In this Order:-

"enactment" means any enactment, whether public general or local, and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment; and

"the Order of 2018" means the Borough of Dacorum (Controlled Parking Zones) Order 2018<sup>4</sup>, as amended.

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (3) Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2018 shall have the same meaning as in that Order.
- 3. Without prejudice to the validity of anything done, or to any liability incurred in respect of any act or omission before the coming into force of this Order:-
  - (a) the Order of 2018 shall have effect as though:
    - (i) there were added to Article 2(1) of that Order the following definitions:""restricted loading area" means an area within the Borough of
      Dacorum specified in column 1, 2 or 3 of Schedule 10A referred to in
      Article 3(1A);"; and

""restricted loading hours", in relation to any restricted loading area, means the time specified at the beginning of Schedule 10A in relation to that restricted loading area;";

(ii) after Article 3(1) of that Order there were inserted the following:-

- "(1A) Subject to the provisions of this Order, any street or part of a street specified in column 1, 2 and 3 of Schedule 10A is a restricted loading area.";
- (iii) after Article 3(2) of that Order there were inserted the following:-
  - "(2A) No person shall cause or permit any vehicle to wait, load or unload during the restricted loading hours in any restricted loading area.";
- (iv) in Article 3(4) of that Order, after the words "A restricted waiting area" there were inserted the words "or a restricted loading area";
- (v) for the item listed as "Heath Lane / East / From its junction with the south kerbline of Cemetery Hill southwards for a distance of approximately 10m." and set out in Schedule 1 to that Order there were substituted the item set out in columns 1, 2 and 3 of Schedule 1 to this Order;
- (vi) the item listed as "Heath Lane / East / From a point in line with the south property boundary wall of 37 Cemetery Hill southwards for a distance of approximately 67m." and set out in Schedule 1 to that Order were omitted;
- (vii) there were added as Schedule 10A to that Order, Schedule 2 to this Order;
- (viii) there were added to Schedule 33 to that Order the items set out in columns 1 and 2 Schedule 3 to this Order; and

- (b) the designation by the Order of 2018 of the parking place listed as "Heath Lane / East / From a point approximately 10m south from its junction with the south kerbline of Cemetery Hill southwards for a distance of approximately 32m." and set out in Schedule 15 to that Order, is hereby revoked.
- 4. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
